# Tax Information Interview

## Consent to electronic 1042-S form

If you do not provide consent for electronic delivery of your tax information reporting statements, you may still use the U.S. tax interview process to complete your IRS W-9 or W-8 form. However, at the end of the calendar year, we will mail your completed tax information reporting statements for your records.

If you provide consent for electronic delivery of your tax information reporting statements, you may revoke this consent at any time by retaking the tax information interview.
